

# **USER AGREEMENT**

**PURPOSE:** This agreement, which is recommended to be used by churches of the S.U.S.U.M.C. Conference, gives permission to use church property/facilities to non-church groups or individuals named in this document as **USER**. The Conference insurance policy covers only certain activities under control of the local church. Non-church groups or individuals using church property/facilities, even though permission has been given, do so with the understanding that losses or liabilities incurred by non-church groups or individuals, **are not covered** by Martha UM church.

- USER** agrees to abide by and obey all laws, ordinances and rules and regulations (made known) by any government unit having jurisdiction in **MUMC'S** locale; the **USER** will not engage in any activities in violation of such laws, rules and regulations.
